ARENAS : if weather permits, all tests will be held on 20x60 meters sand x GGT footing outdoor ring. Entrance made from inside the ring. Warm up in indoor arena sand x GGT footing 20x56.

If heavy rain, all tests will be held in 20x56 meter ring and warm up will be arranged in the same ring in between classes and before ride.

No lunging in the rings - the only area available for lunging is in the sand paddock (stone dust), not leveled.

ASTM APPROVED HELMETS must be worn at all time when riding.

DOGS ALLOWED, only on leash at all times.

NO UNENTERED HORSE ALLOWED.

LIMITED STALLS available for \$25 for the day - need to clean up (not strip) (\$50 deposit).
